# 1. Context

Accessibility in higher education is now a top priority across European universities, driven by legal advancements and a deeper understanding of the diverse needs of students. Despite progress, the challenge to eliminate barriers for students with disabilities is more urgent than ever, as these obstacles significantly impact their participation in university life. Actually, the latest EU statistics highlight a concerning disparity, showing that 20.3% of individuals with disabilities are more likely to leave school early compared to 10.8% of their non-disabled counterparts. Furthermore, only 30.9% of students with disabilities advance to tertiary education.

The concept of accessibility is broad, extending beyond just the physical and digital realms—where significant improvements have been observed—to include curriculum adaptation, inclusive teaching strategies, and individual support, among others. And even today, students with disabilities encounter numerous obstacles, ranging from navigating physically inaccessible environments to accessing suitable study materials and receiving adequate support.

The "Accessibility and Higher Education" AccessibleEU awareness-raising event, organised in collaboration with the University of Porto, aims to be a melting pot of ideas and innovation, bringing together a vibrant mix of university professors, students, administrative and service staff, researchers, and managers from inclusion service offices. Together, they will delve into discussions about best practices, confront challenges, and explore new frontiers in making European universities more accessible. Furthermore, this event aspires to sketch out a European roadmap for the future, advocating for a holistic approach to ensure that accessibility in higher education not only meets current standards but also anticipates the needs and aspirations of the future. This balanced perspective aims to merge practical, on-the-ground experiences with strategic, visionary thinking to create a more inclusive and accessible educational landscape across Europe.
